8. Reminder of former pre-announcements

8.1 National Stock Exchange of India BC 326 / 793

Effective 12 February 2007, the futures and options will be migrated from EC 326 to EC 793. An instrument list is attached (file: migrationfromEC326toEC793).

Effective 12 February 2007, the valuation prices rule will be changed as follows:

Old: Rule 1: statistic type: 12 value type: 1 / trade

New: Rule 17: statistic type: 12 value type: 191 / volume weighted average price (VWAP)

8.2 Reorganization of currency data - change of the security code for national currencies

The supply of quotes for national currencies on instruments having presently security code B (11) will be stopped on 12 March 2007. As of this date currency data will only be delivered on instruments of security type "X" (33) technical currency valoren.

The **Swiss fiscal prices for currencies on EC 200** being now on instruments with security code B (11) will also be migrated to instruments with security type X (33).

The reorganization also comprises **the deletion of duplicate entries for currency pairs**.

Please note that **the announced change of derivative instruments**, whose actual underlying instrument is classified as **security type "B"** and has to be replaced by a new instrument with security code "X" (33), **will not be done on 12 March 2007. It has been postponed until further notice.**
