### 8.1 Reorganization: EC 431 – Allocation of funds per currency to new exchange codes

In order to process and display funds, which are on a single security code and quoted in several currencies, the following reorganization is scheduled for **15 February 2006**:

All funds in **USD** will **remain** on **EC 431**. The funds in **other currencies** will be **removed from EC 431** and allocated to the following new exchange codes and processed there:

EC 705 in GBP  
EC 706 in CHF  
EC 707 in JPY  
EC 708 all other currencies

## 8.2 Reorganization: Volatility Indices of Bank Leu – Change from EC 244 to EC 202
